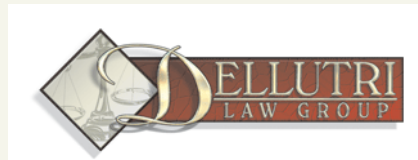
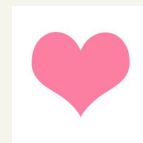

Pillsbury Chocolate Mountain Cookies

Ingredients:

- 1 package Pillsbury Dark Chocolate Chunk Cookie Mix
- 1/3 cup Crisco Vegetable Oil
- 1/4 cup water
- 1 large egg
- 1 cup finely chopped walnuts
- 1/2 cup powdered sugar

Directions:

- Heat oven to 375
- Combine cookie mix, oil, water, and egg in medium bowl. Stir until a soft dough forms. Stir in chopped walnuts. Make balls of dough 1 inch in diameter and place on cookie sheet.
- Bake 8-10 minutes. Cool on cookie sheet for 2 minutes. Roll cooled cookies in powdered sugar, shake off excess.
