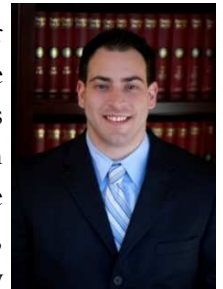
Despite originally thinking that she didn't have a case, our client is extremely happy with the results obtained by Ms. Downing on the case.

In a large bowl combine mascarpone cheese, egg whites and vegetable oil. Using a hand mixer, beat the ingredients until creamy. Add the cake mix and water and mix until smooth, about 3 minutes. Fill the cups to just below the rim and bake until puffed and golden, about 18 to 20 minutes. Remove from oven, let cool slightly in the tin then transfer the cupcakes to a wire rack. Meanwhile, puree the strawberries in a blender or small food processor. Place powdered sugar in a medium bowl. Pour in the strawberry puree and whisk until smooth. Top the cooled cupcakes with the strawberry glaze. Let cupcakes sit for a few minutes for the glaze to firm up, then serve.
