1/2 Cup Plain Yogurt, 1/2
Cup Chocolate Chips

Directions:

Preheat Oven to 325. Grease a
9x5 bread pan. Lightly coat
the pan sides with Flour.

Sift the flour, baking
powder, baking soda, and
salt into mixing bowl and
set aside. With an electric
mixer, cream the butter in
a separate bowl. Gradually
beat in the sugar. Add the
eggs one at a time to the
creamed mixture. Blend in
Vanilla Extract. In another

bowl, stir together the
banana and yogurt. Blend
all 3 mixtures together
slowly, alternating wet and
dry to prevent clumping.

Fold in chocolate chips.

Scrape batter into pan,
smooth the top. Bake for
60-70 Min. or until the top
is golden brown. Let cool.
